DEVIATES *FROM* *THIS* *CLEAR* *PRINCIPLE* *IS*
AIDING, *WILLINGLY* *OR* *UNWILLINGLY*, *THE*

We can see the beginnings of this process to-day in a country like Sweden."

DOLF @ 1656 HOURS ON 10 DECEMBER 2017: "My door has a 'NO COLD CALLERS' notice a fixed to it. There is no requirement to answer my door.

Neither have I had a conversation with you which as being reciprocity and good intentions from or your fascist associates.

Evidence upon which I have published is court evidence and the matter is before the courts

The matter is before the courts and so do cease your attempts to interfere by bullying as aggressive and threatening overtures to interfere in due process as the natural course of justice.

Accordingly I will not comment further."

THAT I HAVE AT THE OWNERS CORPORATION MEETING OF 22 JANUARY 2018 tabled documents in relation to a rescinded parking authority as the removal of a notice by Gippsland Strata Management as addressed by AGENDA ITEM #2 {MINUTES OF PREVIOUS MEETING of 23 JANUARY 2017} and have a bearing upon AGENDA ITEM #6 {DISCUSS ENTITLEMENT/LIABILITY} in relation to parking breaches and an intention to make a claim against the Public Liability Insurance [since withdrawn].

That the Strata Owners Corporate Managers at the 22 January 2018 annual meeting had confirmed their agreement of all matters I had previously and reasonably made including that of the year prior and the outrageous conduct of others as wilful damages, assailment whether

verbal or physical, vilification have no substantiating grounds of factual cause as being prejudiced:

#1 - The indiscriminate recharging of appliances which caused disruption to the television transmission signal was a loss of amenity and therefore prohibited.

#2 - COMMON ACCESS SECURITY DOORS MUST NOT BE IMPEDED WHETHER LOCKED OR KEPT AJAR AND SUCH ACTS MUST IMMEDIATELY CEASE.

#3 - No action to be taken on the Southern fence at this stage. It was agreed to increase the fees to \$750.00 per lot owner from 30/11/18 to cover full replacement of this fence and any issues arising from the safety audit report.

That I had paid this \$250 additional charge upon 23 January and no doubt this will assist repairs of wilful damage to the fence occurring at 2330 hours on 28 January 2018 as revengeful act for a demand of compliance given the Strata Management requirements.

#4 - I had requested a tenant only parking sign & no parking on the grass be erected at the front. (Is to be arranged).

This was in lieu to its improper removal by Strata Management over a year prior when they had affixed contact details of their management of the property.

And a failure to comply with a written request dated 23 August 2017 to re-affix this notice as so to resolve this unnecessary issue of parking infractions as "corrective action [which] is sought so as promote a conducive rapport between neighbours" was not heeded.

2018: "FOR CHRISTIANS ALONGSIDE THE MARTYRDOM OF BLOOD THERE IS A "WHITE MARTYRDOM", WHICH "OCCURS IN DEMOCRATIC COUNTRIES WHEN FREEDOM OF RELIGION IS RESTRICTED," Pope Francis denounced today in his address to the participants in the ***CONSULTA* *OF* *THE* *EQUESTRIAN* *ORDER* *OF* *THE* *HOLY* *SEPULCHRE* *OF* *JERUSALEM***, received this morning in the Clementine Hall.

The group are gathered for their five-year consultation and in this light the Pope recommended they carry forward the testimony of the goodness with which God loves everyone and to help the persecuted Christians "in ever-increasing numbers".

First of all, Francis thanked the knights "for the many spiritual and charitable activities that you carry out for the benefit of the people of the Holy Land".

Addressing the Grand Master Card. Edwin O'Brien, and the pro-gran prior, Msgr. Pierbattista Pizzaballa, the Pope underlined the profuse commitment to face the refugee crisis "that in the last five years has led the Church to provide a significant humanitarian response throughout the region".

And it is a good sign that schools and hospitals of the KNIGHTS OF THE HOLY SEPULCHER are open to all, regardless of the communities they belong to and the religion they profess. "IN THIS WAY YOU HELP TO PAVE THE WAY TO THE KNOWLEDGE OF CHRISTIAN VALUES, TO THE PROMOTION OF INTERRELIGIOUS DIALOGUE, MUTUAL RESPECT AND MUTUAL UNDERSTANDING. IN OTHER WORDS, WITH YOUR MERITORIOUS COMMITMENT, YOU TOO GIVE YOUR CONTRIBUTION TO THE CONSTRUCTION OF THE PATH THAT WILL LEAD, WE ALL HOPE, TO THE ACHIEVEMENT OF PEACE THROUGHOUT THE REGION".

TH[IS] GROWTH OF THE ORDER IN RECENT TIMES, said Francis, depends on the **INCESSANT COMMITMENT OF LOCAL LEADERS OR LIEUTENANTS PRESENT IN OVER 30 NATIONS OF THE WORLD. A DEVELOPMENT THAT IS HOWEVER LINKED TO THE MAIN PURPOSE OF THE KNIGHTS: THEIR OWN SPIRITUAL GROWTH.**

}] of your neighbour as the final aim of your works, to witness everywhere the goodness and care with which God loves everyone ".

It is in fact the task of bishops, priests and deacons admitted to the Order to assist knights with moments of community and liturgical prayer and catechesis.

Francis then recalled the tragedy of persecuted Christians. "THE DRAMATIC SITUATION OF CHRISTIANS WHO ARE PERSECUTED AND KILLED IN EVER-INCREASING NUMBERS IS IN FRONT OF THE WHOLE WORLD - which too often turns its gaze away. In addition to their blood martyrdom, there is also their 'white martyrdom' which occurs in democratic countries when freedom of religion is limited. And this is the daily white martyrdom of the Church in those places ".

The Pope then urged the knights "to always associate the prayer, to constantly invoke Our Lady, whom you venerate with the title of 'Our Lady of Palestine'" to the work of material aid to the populations. Finally, Francis announced the blessing of the icon of OUR LADY OF PERSECUTED CHRISTIANS, which the knights will bring in all the Lieutenancies to accompany them on their journey. And in the final prayer he invoked the special blessing of Mary for the Church in the Holy Land and in the Middle East, "together with her special intercession for those whose life and freedom are in danger". This Church constituted and organized in the world as a society, subsists in the Catholic Church, which is governed by the successor of Peter and by the Bishops in communion with him, although many elements of sanctification and of truth are found outside of its visible structure. These elements, as gifts belonging to the Church of Christ, are forces impelling toward catholic unity.

Haec Ecclesia, in hoc mundo ut societas constituta et ordinata, subsistit in Ecclesia catholica, a successore Petri et Episcopis in eius communione gubernata, licet extra eius compaginem elementa plura sanctificationis et veritatis inveniantur, quae ut dona Ecclesiae Christi propria, ad unitatem catholicam impellunt.

This sentence and the correct meaning of "subsists in" affects the definition of the Church with important implications for how the Catholic Church views itself, its relations with other Christian communities and other religions. Questions have been raised, if Lumen gentium reworded the longstanding phrase, which stated that the Church of Christ is (Latin est) the Catholic Church. ***LUMEN* *GENTIUM* *DOES* *RECOGNIZE* *THAT* *OTHER* *CHRISTIAN* *ECCLESIAL* *COMMUNITIES* *HAVE* *ELEMENTS* *OF* *SANCTIFICATION* *AND* *OF* *TRUTH***.
