INTRODUCTION

The GOOD FRIDAY AGREEMENT (effective 2 December 1999) entered into the vernacular upon 10 APRIL 1998 as an accord between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of Ireland.

However it's secular alignment with the religious calendar creates an existential pre-millennium quandary if not an antagonism involving the ecclesiastical precedence (ie. *Anglican v's Roman Catholic: Saint George Festival and Easter 21 April 2019 calendar conflict*) of the church relative to the Sovereignty of the State (ie. *BREXIT proroguing 17 September 2019*).

Moreover the British sovereign's coronation oath (*although elements have its earliest form from 973 AD at Bath Abbey,*

its antiquity is not known to ourselves, whereas the oath of the PRIVY COUNCIL dates to 1571) is a proclamation that the sovereign is defender of the faith which being established by law as the

REFORMED PROTESTANT RELIGION and such includes upholding the laws of God and the true gospel.

ARCHBISHOP: Will you to the utmost of your power maintain the Laws of God and the true profession of the Gospel? Will you to the utmost of your power maintain in the United Kingdom the Protestant Reformed Religion established by law? Will you maintain and preserve inviolably the settlement of the Church of England, and the doctrine, worship, discipline, and government thereof, as by law established in England? And will you preserve unto the Bishops and Clergy of England, and to the Churches there committed to their charge, all such rights and privileges, as by law do or shall appertain to them or any of them?

QUEEN: All this I promise to do.

Since the affairs of the Church of England are similarly instituted by act of parliament within the AUSTRALIAN COMMONWEALTH it then places upon ourselves an onus to resolve the theological (metaphysical/ metempirical philosophical) meaning of "**utmost of your power maintain the Laws of God and the true profession of the Gospel**" and its consequence upon the ecclesiastical precedence of the church relative to the Sovereignty of the State.

CHERISHED MOTHER WITH CHILD STATUE HAVING AN IRISH NATIONAL IMPOSITION

Your letter dated 15 NOVEMBER 2021 which is a response to our email enquiry of 11 NOVEMBER 2021 in the seeking advice from yourself in clarifying your recollections as the unveiling on 17 MARCH 2017 of the CHERISHED MOTHER WITH CHILD STATUE situated in VICTORIA PARK, SALE.

It was entirely unknown to ourselves until the later plaque placement upon 8 JUNE 2017 what was the actual impetus for this unveiling event which was occasioned (as from a subsequent photograph) by an ornation (ie. *the fact of being ornamented or adorned*) of a leprechaun and from the edition of CATHOLIC LIFE dated APRIL 2017 we determined that the event was also attended by local clergy including Dean of St Mary's Cathedral Friar Peter Bickley.

Such letter of yours however stipulates that "the sculpture commemorates the apology made on behalf of the Australian Government by the then Prime Minister, Julia Gillard, on MARCH 21, 2013, to the people affected by forced adoption or removal policies and practices, and the Victorian Parliamentary apologies delivered by Premier Ted Baillieu and Deputy Premier Peter Ryan on the 25th October 2012."

And whether it was due to your absence at the time as occurring immediately prior to the unveiling event proper is then causal for a lack of any concern over the POLITICAL ACTIVIST's falsely claimed proximity and accosting scenario by alleged repeated intended actions of "VERBAL ABUSE" directed to such person, you nevertheless do not recall any individual conversations which you had with attendees on the day.

Accordingly, you are unable to verify the contradictory and decorous observations made by a WELLINGTON SHIRE COUNCILLOR in accord with his empathetic "PHILOSOPHY IS THAT EVERYBODY DESERVES TO HAVE THEIR VOICE HEARD" as conveyed by email @ 1642 HOURS ON 20 MARCH 2017, specifically: "THEN I HEARD YOU SPEAK BEFORE THE CEREMONY IN VICTORIA PARK, SALE FOR THE UNVEILING OF THE "CHERISHED MOTHER AND CHILD" MONUMENT.

ALTHOUGH YOUR VOICE WAS GOOD AND STRONG WE HAD TROUBLE HEARING. BECAUSE THERE WAS NO INTRODUCTION I WAS NOT IN READINESS TO PAY ATTENTION AT THE START."

That such independent appraisal was made of my prior determined action in only reading a prepared statement and then immediately departing without causing any disturbance or speaking specifically to any person.

Whilst such proclamation directed to the WELLINGTON SHIRE COUNCIL was flourished with vivid descriptions of various prior events, it was made with a specific relevance to the nearby OAK TREE PLANTING of 27 OCTOBER 1934 as then in my view pertaining to the probability of an IRISH REPUBLICANISM CAUSAE COMMUNI possessing a potential of (I quote) "IMPOSING A SUBSTITUTED VIRTUE UPON OUR ANZAC TRADITION AS PERVERSION OF STATE AUTHORITY AND SOVEREIGNTY".

The circumstance of an IRISH REPUBLICANISM CAUSAE COMMUNI being a determined IMPOSITION PLACED UPON THE UNVEILING EVENT OF THE CHERISHED MOTHER WITH CHILD STATUE is further attested to by an audio recording of which the POLITICAL ACTIVIST was advised on the occasion of our first meeting upon 28 MAY 2018 when they were holding a private memorial for a deceased IRISH NATIONAL named CATHY MCMAHON as the founding member of IRISH FIRST MOTHERS who were POLITICAL ACTIVISTS with a concern for the GENOCIDAL COERCION OF IRISH UNWED MOTHERS IN PREGNANCY and the deaths of some 9,000 infants within STATE / ROMAN CATHOLIC institutional care over a period of 70 years.

In that the POLITICAL ACTIVIST takes an accountability for the designation of SAINT PATRICK'S DAY 17 MARCH 2017 as the organised unveiling event and furthermore in reciprocity a picture of the CHERISHED MOTHER WITH CHILD STATUE appears on the IRISH FIRST MOTHERS www-page in the advancement of their POLITICAL ACTIVISM within that country as another dominion.

DISCUSSION ON PLAQUE SHENANIGANS FOLLOWING ATTENDANCE AT WORLD WAR ONE 2018 CENTENNIAL

In being aware from news media reporting that DARREN CHESTER was designated the minister for ANZAC 2018 CENTENNIAL COMMEMORATIONS assisting the Prime Minister and in knowing of his attendance to WORLD WAR I 2018 CENTENNIAL at the Arc de Triomphe Paris France, we had occasion outside the polling booth upon his return, to briefly raise past matters of plaque shenanigans and memorial infidelity prior to the VICTORIAN STATE ELECTION held on 24 NOVEMBER 2018.

He was not then aware of the local OAK TREE PLANTING of 27 OCTOBER 1934 made by the DUKE OF GLOUCESTER (its subsequently stolen plaque was replaced JUNE 2000) as occurring prior to the dedication and opening of the HYDE PARK, SYDNEY WAR MEMORIAL upon 11 NOVEMBER 1934. An example of contemporary political activism at the time 1931 to 1935 is the occurrence of the official opening of the Sydney Harbour Bridge upon Saturday 19 MARCH 1932:

Francis Edward de Groot (born in Dublin, Ireland on 24 October 1888 – 1 April 1969) was a member of the **FASCIST**, **PARAMILITARY ORGANISATION**, **THE NEW GUARD OF AUSTRALIA** (founded in 1931 having 50,000 members at its peak and disbanded 1935), who was most famous for intervening on horseback during the official opening of the Sydney Harbour Bridge on Saturday 19 MARCH 1932, cutting the tape before the Premier of New South Wales, Jack Lang, could do so.

De Groot was also said to have later joined the White Army as a **FASCIST PARAMILITARY GROUP FOUNDED WITHIN VICTORIA IN 1931 AND HEADED BY THE CHIEF COMMISSIONER OF VICTORIA POLICE**, Thomas Blamey. The group, which existed for about eight years from 1931, comprised several senior army officers, including Col. Francis Derham, a Melbourne lawyer, and Lt. Col. Edmund Herring, later Chief Justice of Victoria. Some members had been members of the New Guard, and both groups were involved in street fights with leftist groups. This was reportedly a response to the rise of communism in Australia. Its members stood ready to take up arms to stop a Catholic or communist revolution.

However we were satisfied that involvement by the MINISTER in the unveiling of the Cherished Mother With Child Statue on Saint Patrick's Day was a natural prerogative reliably and honourably made in support of constituents and did not involve maleficence on the MINISTER's part—the result of the elections saw the Nationals receive a vote increase which was a significant **#312 -CONTRADICTION** of the trend within the Saturday 24 NOVEMBER 2018 VICTORIAN STATE ELECTION of the 59th Parliament of Victoria. Where all 88 seats in the Legislative Assembly and all 40 seats in the Legislative Council were up for election.

This memorial infidelity firstly manifests as a habitual disrespect [**SEE APPENDIX ON #449 - EVENTS**] towards the IMPERIAL exercise of SOVEREIGN POWER that was manifested by the federation of the STATES into a COMMONWEALTH of Australia upon 1 JANUARY 1901 occurred during the period of the SECOND BOER WAR (12 OCTOBER 1899 to 31 MAY 1902) which was the first time that Australian and New Zealand soldiers engaged in a collective armed conflict.

The Great star of Africa diamond (largest diamond in the world valued at \$400 million) which to this day appears in the Royal Sceptre was gifted to Edward VII in 1907 so as to help mend relations between Britain and South Africa after the Boer War.

The diamond was set into the sceptre in 1910, and first used at George V's coronation on 22 JUNE 1911 and represented the monarch's "temporal power under God". The second star can be seen in the British Imperial State Crown.

Boer War commemorations occurs on the last Sunday of MAY. Whereas Memorial Day within the USA occurs on the last Monday of MAY.

There was specifically on 8 JUNE 2017 a plaque placement upon the CHERISHED MOTHER WITH NAKED CHILD statue coinciding with an observation of an IMPROPER POPPY WREATH PLACEMENT AT THE BOER WAR MEMORIAL on 10 JUNE 2017. A lack of fresh floral wilting and absence of snail infestation suggests the floral tributes were placed within proximity to 8 JUNE 2017 as CARDINAL PELL's BIRTHDAY rather than in a proper accordance with BOER WAR MEMORIAL DAY which was to be held on Sunday 28 MAY 2017.

As then impetus for the further undertaking of an irregular BOER WAR COMMEMORATION upon **27 OCTOBER 2018** as occurring after the HYDE PARK WAR MEMORIAL, SYDNEY re-dedication (*Son of a King / Grandson of a Queen PLAQUES*) upon SATURDAY **20 OCTOBER 2018** and immediately prior to the WORLD WAR ONE CENTENNIAL ON 11 NOVEMBER 2018 in being a culminating action with a clear intention to abrogate any duty of fidelity towards the sovereign and that such action is likely to be made out of a greater regard of the IRISH REPUBLICAN ACTIVISM exhibited by the historical anti-British Saint Patrick's day parades of 1918 and 1920.

This cause of infidelity towards the BRITISH CROWN made in favour of REPUBLICAN ACTIVISM or UNIONISM finds its earliest known as popular manifestation in the Eureka Rebellion of 3 December 1854 which is perversely held by some to be the birth place of democracy given it was a year before the state constitution was framed Governor Hotham decided to appoint a royal commission to report generally on the gold fields on 16 November 1854 - before Eureka. The Letters Patent, however, were dated 7 December, 1854.

The original Constitution of Victoria was drafted and approved in Melbourne in March 1854 by the first Victorian Legislative Council, and sent to Britain for assent. It was received in London in May 1854 and, after some opposition and delay, was approved (with some amendments) as an Act of the British Parliament in 1855.

It was passed by the United Kingdom Parliament as the Victoria Constitution Act 1855, was granted Royal Assent on 16 July 1855 and was proclaimed in Victoria on 23 November 1855.

Secondly, we have to question whether the slaughter of aboriginals within the Gippsland region as occurring prior to the establishment of the Victoria Police on 8 January 1853 was similarly a symptom of contempt against the crown perpetuated by land holders given grants from the crown and then acting against the crown's interests.

In July 1843 at Warrigal Creek, McMillan and his Highland Brigade surrounded a large group of Gunaikurnai people and mercilessly shot between 60 and 150 men, women and children.

The killings were a reprisal for the murder of Ronald Macalister, who was ambushed by a group of Gunaikurnai men he had chased out of his shop hours earlier.

McMillan led five more massacres after that, at Nuntin, Boney Point, Maffra, Skull Creek and Butchers Creek, but for more than a century they were forgotten by the Europeans, and he was revered as Gippsland's heroic founding father and "discoverer".

Our last example of infidelity towards the BRITISH CROWN made in favour of REPUBLICAN ACTIVISM was the violent anti-British sentiment voiced at 1918 St Patrick's Day march, which culminated in Melbourne council banning the parade in 1919.

On 20 MARCH 1920 Roman Catholic archbishop MANNIX of Saint Patrick's Cathedral East Melbourne turned ST PATRICK'S DAY into a REBELLION AGAINST THE BRITISH CROWN by a parade down BOURKE STREET led by Fourteen Australian VICTORIA CROSS recipients, around 10,000 first world war veterans and throngs of Catholic schoolboys marching behind in a depraved procession while tens of thousands of Melburnians lined the streets and cheered them on.

MANNIX was later that year arrested at sea by the BRITISH navy and was not prosecuted for sedition because such action would galvanise the IRISH REPUBLICAN CAUSE.

The CATHOLIC diocese of SALE is legally subject to governance from Saint Patrick's Cathedral East Melbourne.

That fidelity to the **WORLD WAR ONE 2018 CENTENNIAL** is then only within accord with a proper regard directed to the armed services oath of service towards the person as sovereign and not by persons reconciling the IRISH REPUBLICAN ACTIVISM events of 1918 to 1920.

COVID PANDEMIC DISRUPTS 75TH ANNIVERSARY OF WORLD WAR II COMMEMORATIONS AND THE TIMELINESS OF ANY JUDICIAL PROCESS

On 14 AUGUST 2020 Federal Veterans Affairs Minister DARREN CHESTER alone laid a wreath on the Sale cenotaph PLAQUE (rather than the CENOTAPH proper) to mark 75 years since the end of World War 2. COVID restrictions prevented any RSL members from attending the event.

GIPPSLAND TIMES @ 1200 HOURS ON 17 AUGUST 2020:

"GIPPSLAND MHR and federal Veterans Affairs Minister Darren Chester solemnly laid a wreath on FRIDAY 14 AUGUST 2020 at the Sale Cenotaph outside the memorial hall, privately marking 75 years since the end of World War 2.

Given current COVID-19 restrictions Mr Chester was alone, but the gesture still carried the same degree of meaning and poignancy as any wreath laying service.

Almost a million Australians - men and women - served in World War 2.

They fought in campaigns against Germany, Italy and Japan.

On 14 AUGUST 1945, the Japanese Emperor surrendered unconditionally to the Allies, thus ending World War 2.

Victory in the Pacific Day is commemorated on 15 AUGUST each year.

In cities around Australia 75 years ago, spontaneous rejoicing broke out, and there were wild scenes of celebration.

In his **ADDRESS WHICH HE WAS TO HAVE GIVEN** to mark 75 years since the end of World War 2, SALE RSL PRESIDENT MARTY TANZER said one Sydney resident remembered: "We joined the deliriously happy throng celebrating in the city streets, particularly in Martin Place, which was awash with torn paper, streamers and unrolled ***TOILET*** paper rolls."

In concord with this theme of ***TOILET* v's #1701 - *SOIL*** I had @ **1441 HOURS UPON 7 SEPTEMBER 2018** as prior to the WORLD WAR ONE 2018 CENTENNIAL an improper delivery of toilet blocks sent from the MEMORIAL HALL where there was a categorical clarity as to being directed to my home (**#321 - *PRO* *DOMO***) address and this was consistent with an abnormality ('**SIDEWALK OPPORTUNISM ALONE AS YOUR SELF DECLARED VIRTUE AND DIGNITY**' cf: PROROGUING LETTER DATED 7 JULY 2017 AND LETTER AS DIARY NOTE TO STATE / FEDERAL ATTORNEY GENERALS DATED 8 NOVEMBER 2017) as ***TOILET*** time children's book cover littering within the street after a cenotaph memorial BEER-SHEBA centennial event held there on 28 OCTOBER 2017.

Some days thereafter in Cunninghame Street I congratulated DARREN CHESTER on the strategic wreath placement given the aforementioned observed CHERISHED MOTHER plaque placement contemporaneous to BOER WAR MEMORIAL wreath impropriety.

The COVID pandemic has also had significant impact upon the timeliness of any judicial process subsequent to the initial APPLICATION FOR AN INTERVENTION AND PERSONAL SAFETY ORDER by CASE NUMBER **H13018534** dated 31 OCTOBER 2018. Which was unsuccessfully (ie. *the judge fervently did not want to consider the matter of implausible claims made of identity as the primary cause of appeal*) subject to COUNTY COURT APPEAL as CASE NUMBER **AP-18-0609** on 9 DECEMBER 2019 as having a fictional bearing upon IDENTITY occasioning a perverse administration of justice:

Martin Ludwig Bormann (17 June 1900 – 2 May 1945) as Chief of the Nazi Party Chancellery / Secretary of the Deputy Führer: "You've always been very religious"

I'm going to become a religious figure. Soon I'll be the great chief of the Tartars. Already Arabs and Moroccans are ***MINGLING* *MY* *NAME* *WITH* *THEIR* *PRAYERS***. Amongst the Tartars I shall become Khan.

The only thing of which I shall be incapable is to share the sheiks' mutton with them. I'm a vegetarian, and they must spare me from their meat. If they don't wait too long, I'll fall back on their harems!" [pages 203, 204]

HISTORICAL PRECEDENTS CONVEYING THE FACTUALITY OF ANTI-HOMOSEXUALITY HATRED BY THE RETURNED SERVICES LEAGUE (RSL) AND FREEMASONS AUSTRALIA

EXHIBITED UPON ANZAC DAY 1982, WHEN FIVE GAY MEN WALKED UP TO THE SHRINE OF REMEMBRANCE IN

"I didn't mind the poofters in the march, but they must march with their units," he later told The Age.

RUXTON and the SHRINE COMMISSIONAIRE had a tense discussion with the five men at the top of the stairs.

"Not even there," came the response, according to City Rhythm.

"I don't know where all these gays and poofters have come from," he was later famously quoted as saying, "I don't remember a single one from World War Two."

"As an RSL member, ex-POW and serviceman – I apparently have news for you," the unnamed man told Outrage magazine in 1988.

"There were thousands of ex-servicemen who were camp, I think I went through 300 of them myself," he told the magazine, a copy of which is preserved by the Australian Lesbian and Gay Archives.

While his account can't be verified today, many of the details in his story are corroborated by other sources.

He told the magazine that when his friends joined up, he joined up too.

"You had to be very careful, act butch until you found the ones like you," he said.

A veteran of World War Two, the Australian soldier said he had been held in a POW camp in Greece and then in Germany.

According to Wikipedia, the Book of Jubilees claims to present "the **HISTORY OF THE DIVISION OF THE DAYS OF THE LAW**, of the events of the years, the year-weeks, and the jubilees of the world" as revealed to Moses (in addition to the Torah or "Instruction") by angels while he was on Mount Sinai for forty days and forty nights.

REMEMBER THE SABBATH: "And on the seventh day God ended his work which he had made; and he rested on the seventh day from all his work which he had made.

And God blessed the seventh day, and sanctified it: because that in it he had rested from all his work which God created and made." [Genesis 2:2-3]

HONOUR PARENTS: "And Ham, the father of Canaan, saw the nakedness of his father, and told his two brethren without.

And Shem and Japheth took a garment, and laid it upon both their shoulders, and went backward, and covered the nakedness of their father; and their faces were backward, and they saw not their father's nakedness. And Noah awoke from his wine, and knew what his younger son had done unto him." [Genesis 9:22-24]

THOU SHALT NOT KILL: "And Isaac spake unto Abraham his father, and said, My father: and he said, Here am I, my son. And he said, Behold the fire and the wood: but where is the lamb for a burnt offering?

And Abraham said, My son, God will provide himself a lamb for a burnt offering: so they went both of them together.

And they came to the place which God had told him of; and Abraham built an altar there, and laid the wood in order, and bound Isaac his son, and laid him on the altar upon the wood.

St George's Day is celebrated every year on 23 April, which is believed to be the day that St George was executed after 7 years of torturous captivity.

Due to calendar conflicts Anglicans as prerogative of ecclesiastical precedence and differentiation did mark the patron saint's day on Monday 29 April 2019, while Roman Catholics did transfer the day to 30 April 2019.

It's thought that St George was executed in 303 AD for refusing to renounce his Christian faith in compliance with the Roman Emperor Diocletian's (284 to 305 AD) orders that soldiers make sacrifices to pagan gods.

VOX IN EXCELSO was the name of a **PAPAL BULL** issued by Pope Clement V in 1312. The Poor Fellow-Soldiers of Christ and of the Temple of Solomon (Latin: Pauperes commilitones Christi Templique Salomonici), also known as the Order of Solomon's Temple, the ***KNIGHTS* *TEMPLAR***, or simply as Templars, was a Catholic military order recognised in 1139 by **PAPAL BULL** Omne Datum Optimum (Latin for "Every perfect gift", a quotation from the Epistle of James 1:17) of the Holy See. If the REBORN ***KNIGHTS* *TEMPLAR*** is ostensibly a military as sectarian order having its earliest historical analogies within the dominion of #71 - MITHRAISM (71 AD) as being a cultus engaged in by soldiers to the Imperium of the Roman State. Given its RENEWAL within 2015 would then be mandated by PAPAL imprimatur, a reasonable conclusion to make regarding any WORLD WAR ONE 2018 CENTENNIAL COMMEMORATIONS is that there would be as pretence to piety, a deference shown towards the PAPAL authority as requital rather than towards any individual sovereign state irrespective of their ideological participatory outcomes as either victor or the vanquished.

In the circumstance where the ***KNIGHTS* *TEMPLAR*** had lapsed into the sin of wicked apostasy, the crime of detestable

idolatry, and the execrable outrage of the ***SODOMITES*** resulting in their dissolution with a **PAPAL BULL** issued by Pope Clement V in 1312. Their restitution within 2015 would similarly occur by PAPAL edict granting either an outright amnesty (ie. *an official pardon for people who have been convicted of offences*) or at the very least a clemency (ie. *an exercise of power; leniency, mercy; compassion against the former judgment or punishment*) for the execrable outrageous crimes committed.

Whilst there exists some plurality of opinion as to the nature of any individual or collective church outrage directed towards the ***SODOMITES*** following upon a voracious number of PRIESTLY child sexual abuse cases, the PAPAL appetite subsequently has shown a greater toleration since a person does not choose to be either homosexual or heterosexual, and being gay is not inherently sinful.

Such PAPAL indulgences towards any remissions for the past wicked idolatrous apostasy of the ***KNIGHTS* *TEMPLAR*** has not then had any salutary effect upon the past teachings within the Catechism of the Catholic Church, which still views that "homosexual acts" are "acts of grave depravity" that are "intrinsically disordered." It continues, "They are contrary to the natural law. They close the sexual act to the gift of life. They do not proceed from a genuine affective and sexual complementarity. Under no circumstances can they be approved." Regarding homosexuality as an orientation, the Catechism describes it as "objectively disordered."

Thusly, it is reasonable to conclude that a member of the REBORN ***KNIGHTS* *TEMPLAR*** in having themselves been redeemed from any association to the *execrable outrage of the* ***SODOMITES*** would in all likelihood, as a self justification, then hold a negative value statement about homosexuals.





Saint Joseph's day is a solemnity and per the 1983 Code of Canon Law overrides Friday obligations in the Catholic Church. Previously, per the 1917 Code of Canon Law, the obligation of fasting and abstinence was not dispensed on St. Joseph's Day even where it was kept as a Holy Day of Obligation: "On [Sundays] or feasts of precept, the law of abstinence or of abstinence and fast or of fast only ceases, except during Lent, nor is the vigil anticipated; likewise it ceases on Holy [Saturday] afternoon" (1917 Code, Canon 1252 § 4).

The 54-page text which is titled PRAEDICATE EVANGLIUM, or PROCLAIMING THE GOSPEL is an **apostolic constitution** which becomes effective on **PENTECOST SUNDAY of 5 JUNE 2022** and replaces the founding constitution PASTOR BONUS (Latin: "The Good Shepherd") that was penned by Pope John Paul II in 1988.

An **apostolic constitution** (Latin: constitutio apostolica) is the most solemn form of legislation issued by the Pope. The use of the term constitution comes from Latin constitutio, which referred to any important law issued by the Roman emperor, and is retained in church documents because of the inheritance that the canon law of the Roman Catholic Church received from Roman law.

By their nature, apostolic constitutions are addressed to the public. Generic constitutions use the title apostolic constitution and treat on solemn matters of the church, such as the promulgation of laws or definitive teachings. The forms dogmatic constitution and pastoral constitution are titles sometimes used to be more descriptive as to the document's purpose.

Apostolic constitutions are issued as **PAPAL BULLS** because of their solemn, public form. Among types of papal legislation, apostolic letters issued motu proprio (ie. *without formal request from another party*) are next in solemnity.
