MADE IN RESPONSE TO ADVICE FROM THE WORLD JEWISH CONGRESS OF A REPORTED EVENT WHERE THE "HISTORIC BULGARIAN SYNAGOGUE VANDALIZED" RECEIVED @ 0902 HOURS ON 25 JANUARY 2019: "In yet another example of the antisemitic hatred surging throughout Europe, a man hurled stones through the windows of the Great Prayer Hall of the Sofia Central Synagogue this past Shabbat.

This act of vandalism coming just a week after a monument in the Bulgarian capital honouring the victims of the Communist regime was targeted with antisemitic graffiti, is deeply disturbing.

The World Jewish Congress stands with our community in Bulgaria in decrying this despicable act against a center of Jewish life in Sofia. We urge the authorities to take all necessary measures to ensure the continued safety and well-being of the Bulgarian Jewish community. This is not a simple act of criminal vandalism and should be treated with the severity it deserves.

Jews in Bulgaria are proud and integral members of society, and their security must be of utmost importance and concern, as with all citizens of Bulgaria. It is absolutely unacceptable that the community should have to live in fear or trepidation for their lives or their property, simply due to

their identity as Jews."

And returned home via the BOER WAR MEMORIAL where I had payed my respects as I sometimes do to commence the SABBATH hours.

And returned home @ 2100 hours or thereabouts only to find, in my short absence of some 40 minutes, that my front door had been egged and there was a PRESBYTERIAN CHURCH street sign placed within my garden.

After taking the sign to the ANGLICAN CHURCH opposite (of which the Queen is head) and being of friendly terms with both the Pastor RICH and his wife JULIA as proprietor CAFE #123 with respect to having earlier upon ANZAC DAY 25 April 2018 had a discussion and a sausage / bread with the CHURCH PASTOR whereupon our exact discussion was confirmed by an earthquake later that same day:

That upon my return whilst making an ingress to the property which was being subject to CCTV surveillance, I was met with a #419 - NOISOME AIR HORN as an ambush with the intention by the RESPONDENT to CAUSE A STARTLE REFLEX from behind his otherwise shuttered WINDOWS / DOORS as exhibiting an ABNORMAL interest within my own affairs and private actions.

Out of a reasonable disgust for this premeditated ANTI-SEMITIC action (ie. the PRESBYTERIAN CHURCH street sign had to be obtained prior: My mother had her funeral within this church and on that occasion I wore my POLICE UNIFORM as SERGEANT and read her favourite PSALM 23) I then threw some 6 eggs to the fore area of the RESPONDENT's property in the certain knowledge that since he had habitually engaged by off CCTV camera proximity, the obsessive manner of monitoring my egress / ingress to the property and especially given it was the SABBATH hours, tomorrow being Australia Day and Sunday is Holocaust #273 - REMEMBRANCE DAY. And whereupon the year prior on that day he had caused some initial \$5000 wilful criminal damages to my car which despite my being within the stationary vehicle and witness to the event, he has never been pursued by the INSURER for any RECOVERY nor charged with and CRIMINAL OFFENCE due to the VICTORIA POLICE giving tacit approval to continual acts of RACIAL HATRED, ANTI-SEMITISM and

PSYCHO-SEXUAL PREJUDICE.

At 2014 hours I heard water flushing against the external wall of my apartment (which was abnormal even given the prolific thunderstorm prior) and I went out to determine what it was. And despite having his strongly luminous torch light intentionally shone into my face so as to cause blindness which was accompanied by a stream of water into my face as attempts to conceal the identity of the intruder, I determined that it was my neighbour and against whom there are existing INTERVENTION ORDERS engaging with REVENGEFUL CONDUCT which were clear breaches of those COURT ORDERS.

THAT A LODGEMENT OF A COUNTY COURT APPEAL AS CASE NUMBER: AP-18-0609 WAS MADE AGAINST THE SALE MAGISTRATES COURT GRANTING UPON 14 MARCH 2018 AN APPLICATION FOR AN INTERVENTION AND PERSONAL SAFETY ORDER WITHIN CASE NUMBER: **H13018534**

THIS WAS DUE PRIMARILY TO AN ABJECT LACK OF ANY PROCEDURAL FAIRNESS AND ACCORDING OF DUE PROCESS AS THE NATURAL COURSE OF JUSTICE IN RELATION TO CASE NUMBER H12143475 (AS COUNTY COURT APPEAL CASE NUMBER: AP-18-0775) THAT WAS INITIALLY LODGED AT THE SALE MAGISTRATES COURT ON 31 JULY 2017 AND ADJOURNED FOR NON EXISTENT GROUNDS OF THE RESPONDENT WISHING TO CONTEST THE MATTER UPON 13 SEPTEMBER AND THE PROCESS WAS INTENTIONALLY FRUSTRATED UNTIL 11 APRIL 2018 AS TO PRE-SUPPOSE THERE BEING A PREMEDITATION BY OTHERS TO COLLECTIVELY ENGAGE WITHIN A **COMMON LAW OFFENCE OF** PERVERTING THE COURSE OF JUSTICE AND BY TESTIMONY KNOWN AT THE TIME TO BE FALSE AND CONTRADICTORY AS CONSTITUTING PERJURY:

**#3:** ON 31.7.2017 AT 10AM [THE RESPONDENT] SHOWED ME A PHOTOGRAPH OF THE MARION STATUE WITH[IN] THE PARK OPPOSITE WEARING A BALACLAVA AS TO CONVEY OUR MUTUAL UNDERSTAND[ING] OF IT['S] PLACEMENT AS **\*AN\* \*ATTEMPT\* [\*TO\*] \*SUBVERT\* \*OUR\* \*AUSTRALIAN\* \*HISTORY\* \*WHICH\***

**\*IS\* \*ABSENT\* \*OF\* \*ROMAN\* \*CATHOLIC\* \*IMPOSITIONS\*

**#4:** AT ABOUT 1.40PM I RETURNED HOME FROM LUNCH AT A CAFE WITH A BAG OF CHIPS FOR [THE RESPONDENT] [AND] WAS CONVEYING TO HIM IN THE PRESENCE OF HIS MOTHER THAT I HAD DISCOVERED THE COMMON ELEMENT OF ASSOCIATION FOR THIS CAUSE CÉLÈBRE OF CLANDESTINED STALKING AND OPPOSITION TO WHICH I WAS BEING SUBJECT FOR SOME 20 YEARS AS BEING, SAINT ANDREW'S DAY WHICH IS THE FEAST DAY THAT IS CELEBRATED ON 30 NOVEMBER.

**#5:** BEFORE I COULD ACTUALLY CONVEY THAT QUINTESSENTIAL OBSERVATION AS THE FACT OF COMMON ASSOCIATION A[ND] CAUSE CÉLÈBRE [FOR] CLANDESTINED STALKING AND OPPOSITION WHICH VALIDATED HIS EARLIER PHOTOGRAPHIC PREMISE MADE THAT MORNING.

**#7:** ON 24.3.2017 I HAD TO CALL 000 NOT FOR ANY PARTICULAR EMERGENCY (BUT FOR NOTHING OTHER THAN M[Y] OWN URGENT NEED) BECAUSE A VISITOR TO [THE RESPONDENT] WOULD NOT MOVE HIS CAR FROM TOTALLY AND HABITUALLY IMPEDING ACCESS.

**#8:** AND HE WAS SO STUPID, THAT HE IMMEDIATELY PARKED IT [BACK] WHERE IT WAS (ERRONEOUSLY PARKED) AND FIVE MINUTES LATER I RETURNED FROM **\*MY\* \*URGENT\* \*ANTI\*-\*TERRORISM\* \*DUTY\*  
\*ASSISTING\* \*THE\* \*GOVERNOR\* \*GENERAL\*** AND WAS UNDERSTANDABLY MOST OUTRAGED THAT I HAD [TO] ASK MORE FORCIBLY THAT HE ENTIRELY MOVE THE CAR AND PARK IT MORE APPROPRIATELY WITHIN A DESIGNATED PARKING AREA.

Having had this reasonable request denied by the COURT to accord me **PROCEDURAL FAIRNESS AND ANY CONSIDERATION OF DUE PROCESS WITHIN MY EXISTING AND RELATED MATTERS**, I lodged an appeal with only preliminary summary of evidence against the 14 MARCH 2018 granting of an this intervention order within **CASE NUMBER H13018534** as being a miscarriage of justice.

Since I had confronted this attack against my property and could identify the intruder as being the RESPONDENT, he then proceeded to assault me... by punching me several times to the mouth and nose which caused my glasses to fall off and slide towards the shrub at the fence opposite to UNIT #3.

He repeatedly grabbed hold of me with an intention to totally restrain my capacity to return to my dwelling and with an aggressive manner attempted side stomp upon my right leg causing an immediate protuberance of large and abnormal swelling as that which he had broken upon 23 November 2017 with no apology ever since, by a repeated instance of unreasoned pursuit, haranguing which then occasioned an intentioned tumult preventing any opportunity for a safe retreat within the street / park area, although which occurring in the presence of independent witnesses whom I had urgently asked to call for EMERGENCY ASSISTANCE, he has never been charged with a CRIMINAL OFFENCE due to the VICTORIA POLICE giving tacit approval to continual acts of RACIAL HATRED, ANTI-SEMITISM and PSYCHO-SEXUAL PREJUDICE.

At one point, we both fell to the concrete and fortunately, whereby I had wrestled him down upon me so as to prevent the aggressive manner of attempted side stomping of my leg resulting within the prospect of his kicking any further parts of my body which was then in a position of vulnerability on the ground.

Although he made some statement about his displeasure in having his front entrance egged in a similar manner (which due to the temporal / proximity / opportunity / manner of action by its circumstantiality could only be undertaken by the RESPONDENT or his ASSOCIATES specifically tasked for such retribution) the physicality of the malee made any opportunity for rational speech totally impractical.

This, due to the futility of POLICE ACTION and the IMPOSSIBILITY OF EVER ATTAINING ANY SENSE OF FAIR AND EQUITABLE JUSTICE WITHIN THE COMMONWEALTH OF AUSTRALIA has been my only act of initiation or reciprocation since I had LODGED my APPLICATION FOR AN

INTERVENTION AND PERSONAL SAFETY ORDER AT THE SALE  
MAGISTRATES COURT ON 31 JULY 2017 against the RESPONDENT'S  
frequent AUSTRALIAN NATIONALISM (ie. **HE HAS PRESENTED THE  
EUREKA FLAG WITHIN HIS WINDOW AS A DECLARATION OF  
CONTEMPT AGAINST ANY #873 - PROBITY TOWARDS #115 -  
DIGNITY ROYAL**) OCCASIONING ANZAC CENTENNIAL  
COMMEMORATIONS AS #371 - CAUSE CÉLÈBRE BULLYING AND  
CRIMINAL conduct which have now resulted in over \$25,000 car (x 3  
occasions) and property damages, although reported to the VICTORIA  
POLICE has resulted in no action by them.

Once I escaped from this VIOLENT AS UNREASONED ATTACK and  
returned to the safety of my dwelling with bloodied wounds to the nose,  
mouth and right knee, I then activated my PERSONAL SAFETY DURESS  
ALARM and requested that the monitoring agency CHUBB SECURITY  
initiate the procedure for EMERGENCY POLICE attendance.

Given the protuberance of large and abnormal swelling as a reasonable  
possibility of complications to the titanium rod insertion within my leg, I  
advised the SECURITY AGENCY that I would by pedestrian means as best  
as I could, immediately attend to the SALE HOSPITAL EMERGENCY  
DEPARTMENT and requested that the police make any visitation to me  
there.

The POLICE were within attendance to my APARTMENT @ 2133 HOURS  
and remained there surveying the area for some 30 minutes. They  
subsequently attended to me in the EMERGENCY DEPARTMENT @ 2220  
HOURS. They obtained photos of wounds and made arrangements for my  
providing a STATEMENT relating to this matter after 1500 HOURS ON  
SATURDAY 26 JANUARY 2019 as requesting my attendance at the SALE  
POLICE STATION.

That I also provided to the POLICE the document titled "**GREAT #273 -  
MOMENTS AT THE WORLD ECONOMIC FORUM (22 TO 25 JANUARY  
2019) ON THE #364 - QUESTION OF CLIMATE CHANGE AS BEING  
LOGICAL #312 - CONTRADICTIONS ADVANCED DURING DEBATE**"  
in addition to a copy of the document lodged at 1729 HOURS within the
